

# **Agreement of Cooperation**

Between

**Pavlo Chubynsky Academy of Arts, Communal Higher Educational  
Establishment of Kyiv Regional Council**

and

**Academy of Music, Theatre and Fine Arts, Chisinau, Republic of Moldova**

01 June 2026

**Pavlo Chubynsky Academy of Arts, Communal Higher Educational Establishment of Kyiv Regional Council**, represented by Rector **Vasyl Romanchyshyn**, acting on the basis of the Charter, and **Academy of Music, Theatre and Fine Arts, Chisinau, Republic of Moldova**, represented by Rector **Victoria Melnic**, acting on the basis of the Charter, hereinafter jointly referred to as the “Parties,” guided by the intention to create the most favorable mutually beneficial conditions for cultural and educational cooperation, combining their efforts for the purpose of promoting mutual exchange of experience on the basis of mutual respect and friendship, hereby conclude this Cooperation Agreement (hereinafter referred to as the “Agreement”) and establish partnership relations based on the principles of mutual benefit and joint educational and cultural development.

1. This Agreement is aimed at the development of international cooperation in the field of education and cultural exchange and is intended to expand international mutual understanding, improve the quality of higher education training, enhance the content of education, and develop and strengthen friendly relations between both Parties.
2. International cooperation shall include the following areas:

- 1) Cooperation in the field of education and cultural activities;
- 2) exchange of experience in organizing the educational process and teaching methodologies;
- 3) exchange of students under mutual exchange programs (creative/artistic competitions, festivals, etc.);
- 4) joint participation in international educational and cultural programs, projects, and exchanges for the purpose of implementing academic mobility;
- 5) organization and holding of joint academic events, conferences, and seminars;
- 6) other activities considered mutually beneficial.

The above-mentioned areas of cooperation do not exclude the possibility of expanding their scope.

3. The implementation of each international program shall be discussed and agreed upon by both Parties. Prior to the commencement of any international program, a written agreement specifying the details of the program implementation within the framework of this Agreement shall be concluded.

4. Under this Agreement, the Parties shall not undertake any mutual financial obligations.

5. The Parties undertake, within their capabilities, to ensure the creation of the necessary organizational and economic conditions for cooperation and for the fulfillment of the objectives set forth in this Agreement.

Each Party shall independently secure the funds necessary for the implementation of this Agreement. For the implementation of this Agreement, each Party shall allocate funds exclusively within the limits of the respective financing available at its disposal.

6. This Agreement shall be concluded for a period of five years and shall remain in force unless either Party initiates its termination.

7. This Cooperation Agreement may be terminated by either Party through written notice to the other Party two months prior to the termination of the Agreement.

Any amendments and supplements may be made only upon mutual consent of both Parties and exclusively in written form.

If neither Party expresses its intention to terminate this Agreement, the Agreement shall be automatically extended for the same period and under the same conditions.

8. This Agreement is executed in two original copies, one for each Party, each having equal legal force.

9. This Cooperation Agreement shall enter into force upon its signing by both Parties.
